**NYS Senate Democrats on track to hold onto majority
(size of majority be confirmed but expect at least 40 seats, down from high of 43 seats)**

**NYS Assembly: Several longtime Assembly Democratic incumbents defeated,
Assembly Democrats expected to hold 100-103 seats (down from high of 107 seats)**

I. Introduction

As of the drafting of this report, the balance of power in Washington is still undetermined in a mid-term election cycle that defied historical trends and will go down as one of the most expensive as \$16.7 billion is projected to have been spent between federal and state elections, according to the non-partisan OpenSecrets.org. With a total of 435 seats in the U.S. House of Representatives, 30 remain too close to call. Currently, 212 Republican victors have been confirmed and 204 Democrats have been confirmed presenting a pickup of 17 seats for Republicans and five for Democrats with the outcome of 19 more races still outstanding, according to CNN.¹ Over the weekend of November 11-November 13, 2022, the races for US Senate in Arizona and Nevada were called in favor of the Democratic incumbents, Mark Kelly and Catherine Cortez-Masto respectively, giving Senate Democrats control of the chamber with 50 seats and Vice President Kamala Harris as the tie breaker. Both parties are now looking to pick up the one remaining seat in Georgia in the December 6, 2022, runoff.

At the state level, after an exceedingly contentious election season, history was made when New York elected its first woman to its highest office. Governor Kathy Hochul (D) won a hard-fought battle against Congressman Lee Zeldin who came from behind in a race the pollsters had pegged as nearly a dead heat entering the final weekend of the campaign. In the end, 43% of New York's 13.1 million registered voters casted a ballot, compared to the 48% turnout in 2018 gubernatorial election.

In the State Senate, Republicans picked up several seats (the final number yet to be determined) while Democrats appear to be on track to hold 40 of the 63 seats, down from the supermajority of 43 seats, which allowed for an override of a gubernatorial veto. In the Assembly, Democrats' supermajority of 107 members is on track to be reduced to between 100 and 103 seats but enough to maintain the ability override a gubernatorial veto. The enclosed report covers the preliminary results for Congress, Senate, Assembly, and the one ballot proposal.

II. Congress

Heading into this election cycle, Democrats controlled 19 seats Republicans 8 seats. As a result of the 2020 census, New York lost one congressional seat decreasing from 27 to 26. New Yorkers elected the following 26 to Congress: 15 Democrats and 11 Republicans who were able to flip four seats in the 3rd, 4th, 17th and 19th congressional districts.

- 1st District (Part of Suffolk) – **OPEN SEAT: REPUBLICANS MAINTAIN** (formerly held by Lee Zeldin who ran for Governor) – **Republican/Conservative Nicholas J. LaLota** prevailed over Democrat Bridget Fleming 54% to 43% with 566 of 566 election districts reporting.
- 2nd District (Part of Nassau & Part of Suffolk) – **REPUBLICANS MAINTAIN** – **U.S. Representative Andrew R. Garbarino (R/C)** prevailed over Democrat Jackie Gordon 59% to 38% with 514 of 514 election districts reporting.
- 3rd District (Part of Nassau & Part of Queens) – **OPEN SEAT: REPUBLICAN PICKUP** (formerly held by Democrat Tom Suozzi) – **Republican/Conservative George A.D. Santos** prevailed over Democrat Robert P. Zimmerman 53% to 44% with 578 of 578 election districts reporting.
- 4th District (Part of Nassau) – **OPEN SEAT: REPUBLICANS PICKUP** (formerly held by Democrat Kathleen Rice) – **Republican/Conservative Anthony P. D’Esposito** prevailed over Democrat Laura A. Gillen 51% to 47% with 581 of 581 election districts reporting.
- 5th District (Part of Queens) – **DEMOCRATS MAINTAIN** – **U.S. Representative Gregory W. Meeks (D)** prevailed over Republican/Conservative Paul King 72% to 24% with 460 of 460 election districts reporting.
- 6th District (Part of Queens) – **DEMOCRATS MAINTAIN** – **U.S. Representative Grace Meng (D)** prevailed over Republican/Conservative/Medical Freedom party candidate Thomas J. Zmich 61% to 35% with 399 of 399 election districts reporting.
- 7th District (Part of Kings & Part of Queens) – **DEMOCRATS MAINTAIN** – **U.S. Representative Nydia M. Velazquez (D)** prevailed over Republican/Conservative Juan Pagan 77% to 19% with 402 of 402 election districts reporting.
- 8th District (Part of Kings) – **DEMOCRATS MAINTAIN** – **U.S. Representative Hakeem S. Jeffries (D)** prevailed over Republican/Conservative Yuri Dashevsky 69% to 26% with 378 of 378 election districts reporting.
- 9th District (Part of Kings) – **DEMOCRATS MAINTAIN** – **U.S. Representative Yvette D. Clarke (D)** prevailed over Conservative Menachem M. Raitport 71% to 15% with 373 of 373 election districts reporting.
- 10th District (Part of Kings & Part of New York) – **DEMOCRATS MAINTAIN** – **Democrat Daniel Goldman** prevailed over Republican/Conservative Benine A. Hamdan and Medical Freedom candidate Steve F. Speer with 79% of the vote (431 of 431 election districts reporting).
- 11th District (Richmond & Part of Kings) – **REPUBLICANS MAINTAIN** – In a rematch from 2020, **U.S. Representative Nicole Malliotakis (R/C)** once again prevailed over Democrat Max N. Rose 61% to 37% with 374 of 374 election districts reporting.
- 12th District (Part of New York) – **DEMOCRATS MAINTAIN** – **U.S. Representative Jerrold L. Nadler (D)** prevailed over Republican/Conservative Michael K. Zumbuskas 80% to 18% with 400 of 400 election districts reporting.
- 13th District (Part of Bronx & Part of New York) – **DEMOCRATS MAINTAIN: UNOPPOSED** – **U.S. Representative Adriano Espaillat (D)** received 109,014 votes.
- 14th District (Part of Bronx & Part of Queens) – **DEMOCRATS MAINTAIN** – **U.S. Representative Alexandria Ocasio-Cortez** prevailed over Republican Tina Forte and Conservative Desi Cuellar with 67% of the vote (434 of 434 election districts reporting).
- 15th District (Part of Bronx) – **DEMOCRATS MAINTAIN** – **U.S. Representative Ritchie Torres (D)** prevailed over Republican Stylo A. Sapaskis 75% to 16% with 361 of 361 election districts reporting.
- 16th District (Part of Bronx & Part of Westchester) – **DEMOCRATS MAINTAIN** – **U.S. Representative Jamaal Bowman (D)** prevailed over Republican Miriam L. Flisser 58% to 35% with 665 of 703 election districts reporting.
- 17th District (Putnam, Rockland, Part of Dutchess & Part of Westchester) – **REPUBLICANS PICKUP** – **Republican/conservative Michael V. Lawler**, current Assemblymember, prevailed over U.S. Representative Sean Patrick Maloney (D), Chair of the Democratic Congressional Campaign Committee, 51% to 46% with 763 of 774 election districts reporting.
- 18th District (Orange, Part of Dutchess & Part of Ulster) – **DEMOCRATS MAINTAIN** – **U.S. Representative Pat Ryan (D)**, who won a special election in the 19th District earlier this summer, prevailed over

Republican/Conservative Colin J. Schmitt, current Assemblymember, 49.37% to 48.56% (a difference of 2,173 votes) with 623 of 623 election districts reporting.

- 19th District (Broome, Chenango, Columbia, Cortland, Delaware, Greene, Sullivan, Tioga, Tompkins, Part of Otsego & Part of Ulster) – **REPUBLICANS PICKUP** – **Republican/Conservative Marcus Molinaro**, current Dutchess County Executive and former Assemblymember, prevailed over Democrat Josh Riley 50% to 48% with 642 of 642 election districts reporting.
- 20th District (Albany, Saratoga, Schenectady & Part of Rensselaer) – **DEMOCRATS MAINTAIN** – **U.S. Representative Paul D. Tonko** prevailed over Republican/Conservative Elizabeth L. Joy 54% to 45% with 642 of 642 election districts reporting.
- 21st District (Clinton, Essex, Franklin, Fulton, Hamilton, Herkimer, Lewis, Montgomery, St. Lawrence, Schoharie, Warren, Washington, Part of Jefferson, Part of Otsego & Part of Rensselaer) – **REPUBLICANS MAINTAIN** – **U.S. Representative Elise M. Stefanik (R/C)** prevailed over Democrat Matt Castelli 59% to 40% with 594 of 594 election districts reporting.
- 22nd District (Madison, Oneida, Onondaga & Part of Oswego) – **OPEN SEAT: REPUBLICANS MAINTAIN** – **Republican/Conservative Brandon M. Williams** prevailed over Democrat Francis Conole 50% to 48% with 678 of 678 election districts reporting.
- 23rd District (Allegany, Cattaraugus, Chautauqua, Chemung, Schuyler, Steuben & Part of Erie) – **OPEN SEAT** – **REPUBLICANS MAINTAIN** – **Republican Nick Langworthy** prevailed over Democrat Max H. Della Pia 63% to 34% with 667 of 667 election districts reporting.
- 24th District (Cayuga, Genesee, Livingston, Ontario, Seneca, Wayne, Wyoming, Yates, Part of Jefferson, Part of Niagara, Part of Orleans & Part of Oswego) – **REPUBLICANS MAINTAIN** – **U.S. Representative Claudia Tenney (R)** prevailed over Democrat Steven Holden 64% to 33% with 720 of 720 election districts reporting.
- 25th District (Monroe & Part of Orleans) – **DEMOCRATS MAINTAIN** – **U.S. Representative Joseph D. Morelle (D)** prevailed over Republican/Conservative La'Ron D. Singletary 53.6% to 46.3% with 98% of the vote in.
- 26th District (Part of Erie & Part of Niagara) – **DEMOCRATS MAINTAIN** – **U.S. Representative Brian Higgins (D)** prevailed over Republican/Conservative Steven L. Sams, II 62% to 35% with 722 of 722 election districts reporting.

III. Governor

Governor Kathy Hochul and Lieutenant Governor Antonio Delgado (D) prevailed over U.S. Representative and former State Senator Lee Zeldin and Lieutenant Governor candidate Alison Esposito (R) 52% to 47% with 13,328 of 14,246 election districts reporting. Governor Hochul is the first female to be elected Governor in New York State.

IV. NYS Comptroller

Incumbent New York State Comptroller **Thomas P. DiNapoli** won a fifth term prevailing over Paul Rodriguez, a financial analyst and veteran of Wall Street, 55% to 42% with 13,378 of 14,296 election districts reporting.

V. Attorney General

Incumbent New York State Attorney General Letitia A. James prevailed over Republican/Conservative Michael Henry, an attorney and owner of New York City law firm specializing in commercial litigation, creditor bankruptcy and PACA Trust, 53% to 45% with 13,378 of 14,296 election districts reporting.

VI. U.S. Senate

U.S. Senate Majority Leader Charles Schumer (D) prevailed over Republican/Conservative Joe Pinion, former anchor on the conservative cable news channel Newsmax, 55% to 43% with 13,378 of 14,296. U.S. Senator Schumer now becomes the longest serving senator in New York State history.

VII. NYS Senate

Heading into the 2022 election cycle, Senate Democrats held 43 of the 63 seats in the Senate with Republicans holding 20. Senate Democrats do not appear to have maintained the forty-two seats needed to be able to

have a supermajority and thus the ability to override a gubernatorial veto. The final tallies have yet to be configured but we do know Democrats appeared to have flipped two seats in the 4th and 52nd districts, while Republicans flipped seats in the 5th, 7th, 8th, 9th, 38th, and 39th districts. Here is a breakdown:

- 1st Senate District (Part of Suffolk) – **REPUBLICANS MAINTAIN** – **Senator Anthony H. Palumbo (R/C)** prevailed over Democrat and Working Families Party candidate Skyler Q. Johnson 55% to 42% with 211 of 211 election districts reporting.
- 2nd Senate District (Part of Suffolk) – **REPUBLICANS MAINTAIN** – **Senator Mario R. Mattera (R/C)** prevailed over Democrat/Working Families Party candidate Susan A. Berland, an attorney, adjunct law professor at Hofstra University School of Law, a former Suffolk County Legislator and NYS Assistant Attorney General, 57% to 41% with 270 of 270 election districts reporting.
- 3rd Senate District (Part of Suffolk) – **OPEN SEAT: REPUBLICANS MAINTAIN** – As a result of redistricting the current incumbent, Senator Alexis Weik (R) opted to run for re-election in the eight Senate District. **Republican/Conservative Dean Murray**, a former Assemblymember from 2018 candidate for State Senate and small business owner who has the backing of Newsday, prevailed over Democrat Farzeen A. Bham, a 20-year-old Stony Brook University student 63% to 33% with 199 of 199 election districts reporting.
- 4th Senate District (Part of Suffolk) – **OPEN SEAT: DEMOCRATIC PICKUP** – Incumbent Senator Phil Boyle (R) opted to not run for re-election. **Democrat Monica R. Martinez**, a former Senator who lost re-election in 2020, leads Republican/Conservative Wendy Rodriguez, a business owner, 49% to 47% with 201 of 201 election districts reporting.
- 5th Senate District (Part of Nassau) – **OPEN SEAT: REPUBLICANS PICKUP** – Incumbent Senator James Gaughran (D) opted to not seek re-election after the redistricting process. Senator John Brooks (D), Chair of Senate Committee on Veterans, Homeland Security and Emergency Preparedness, who currently represents the 8th Senate District opted to run in this district and squared off against Republican Steven D. Rhoads, an attorney, Nassau County Legislator and volunteer firefighter. **Republican Steven D. Rhoads** prevailed over Senator Brooks 59% to 38% with 257 of 257 election districts reporting.
- 6th Senate District (Part of Nassau) – **DEMOCRATS MAINTAIN** – **Senator Kevin M. Thomas (D)** prevailed over Republican/Conservative James L. Coll, a retired police officer and detective for NYPD and current adjunct professor at Nassau Community College 57% to 39% with 233 of 233 election districts reporting.
- 7th Senate District (Part of Nassau) – **REPUBLICANS PICKUP** – Two-term incumbent Senator Anna Kaplan (D) lost to **Republican/Conservative Jack M. Martins**, an attorney who previously represented the district in the Senate from 2011 to 2016 who received the endorsement of Newsday, 52% to 45% with 264 of 264 election districts reporting.
- 8th Senate District (Part of Nassau & Part of Suffolk) – **REPUBLICANS PICKUP** – The current incumbent, Senator John Brooks (D) opted to run in the fifth Senate District. **Republican/Conservative Alexis Weik**, currently freshman Senator for the 3rd Senate District, prevailed over Democrat John R. Alberts, who has worked for Suffolk County Board of Elections for more than a decade and one-half most recently as Assistant Commissioner, 67% to 29% with 253 of 253 of election districts reporting.
- 9th Senate District (Part of Nassau) – **OPEN SEAT: REPUBLICANS PICKUP** – Senator Todd Kaminsky (D) resigned from the Senate earlier this summer. **Republican/Conservative Patricia M. Canzoneri-Fitzpatrick**, an attorney and certified public accountant, president of the Steven McDonald Memorial Corporation, and member of the Malverne village board prevailed over Democrat and Working Families Party candidate Kenneth M. Moore, Mayor of the Village of Bellerose and a retired union sheet metal worker, 54% to 42% with 246 of 246 election districts reporting.
- 11th Senate District (Part of Bronx & Part of Queens) – **DEMOCRATS MAINTAIN** – As a result of redistricting, Senator John Liu (D) opted to run in the 16th Senate District. Longtime **incumbent Senator Toby Ann Stavisky (D)**, Chair of Senate Higher Education Committee, prevailed in this new district encompassing a lot of new territory in the Bronx, against Republican/Conservative Stefano Forte, a former Republican campaign manager, 54% to 43% with 221 of 221 election districts reporting.
- 15th Senate District (Part of Queens) – **DEMOCRATS MAINTAIN** – **Senator Joseph P. Addabbo, Jr. (D)** prevailed over Republican/Conservative/Independent/Medical Freedom candidate Danniell S. Mai, 55% to 42% with 154 of 154 election districts reporting.
- 16th Senate District (Part of Queens) – **DEMOCRATS MAINTAIN** – **Senator John C. Liu (D)** prevailed Republican/conservative/Independent Ruben D. Cruz, II, owner of consulting company and chairperson of the Latin American Intercultural Alliance 56% to 41% with 154 of 154 election districts reporting.

- 17th Senate District (Part of Kings) – TOO CLOSE TO CALL – **I Wen Chu**, a former television journalist who immigrated from Taiwan and most recently served as chief of staff for Assemblymember Peter Abbate leads Republican/Conservative Vito J. LaBella, a retired lieutenant in NYPD, actor and co-founder of PLACE NYC, an educational advocacy organization 48.3% to 47.7% with 123 of 123 election districts reporting. (Race has not been called officially)
- 21st Senate District (Part of Kings) – **DEMOCRATS MAINTAIN** – **Senator Kevin Parker (D)** prevailed in the general election against a primary challenger David Alexis on the Working Families Party line 66% to 16% with 157 of 157 election districts reporting.
- 22nd Senate District (Part of Kings) – **DEMOCRATS MAINTAIN** – **Senator Simcha Felder (D/R/C)** prevailed over Working Families Party candidate Marva C. Brown with 92% of the vote with 144 of 144 election districts reporting.
- 23rd Senate District (Part of Kings & Part of Richmond) – **OPEN SEAT: DEMOCRATS MAINTAIN** – Senator Diane Savino (D) opted to not seek re-election. **Democrat Jessica Scarcella-Spanton**, a former staffer for Senator Savino, prevailed over Republican/Conservative Joseph L. Tirone, Jr., a real estate broker 49% to 46% with 162 of 162 election districts reporting.
- 26th Senate District (Part of Kings & Part of New York) – **DEMOCRATS MAINTAIN** – **Senator Andrew S. Gounardes (D)**, who currently represents the 22nd Senate District, prevailed over Republican/Conservative Brian Fox and Medical Freedom candidate Martha M. Rowen 77% to 20% with 201 of 201 election districts reporting.
- 27th Senate District (Part of New York) – **DEMOCRATS MAINTAIN** – **Senator Brian Kavanagh (D)** prevailed over Medical Freedom party candidate Eric J. Rassi with 80% of the vote with 163 of 163 election districts reporting.
- 28th Senate District (Part of New York) – **DEMOCRATS MAINTAIN** – **Senator Liz Krueger (D)**, Chair of Senate Finance Committee, prevailed over Republican Awadhesh Kumar Gupta 76% to 22% with 160 of 160 election districts reporting.
- 31st Senate District (Part of Bronx & Part of New York) – **DEMOCRATS MAINTAIN** – **Senator Robert Jackson (D)** prevailed over Republican Donald Skinner 76% to 13% with 160 of 160 election districts reporting.
- 32nd Senate District (Part of Bronx) – **Senator Luis R. Sepulveda (D)** prevailed over Republican Antonio Melendez, Sr. and Conservative Dion Jordan Powell with 73% of the vote and 148 of 148 election districts reporting.
- 34th Senate District (Part of Bronx & Part of Westchester) – **OPEN SEAT: DEMOCRATS MAINTAIN** – Senator Alessandra Biaggi (D) opted to run for Congress instead of re-election to State Senate. **Democrat Nathalia Fernandez**, who currently represents the 80th Assembly District, prevailed over Republican/Conservative Samantha Zherka, a small business owner, 59% to 32% with 186 of 187 election districts reporting.
- 35th Senate District (Part of Westchester) **DEMOCRATS MAINTAIN** – **Senate Majority Leader Andrea Stewart-Cousins (D)** prevailed over Republican Kristen M. Kerr 59% to 36% with 313 of 322 election districts reporting.
- 37th Senate District (Part of Westchester) – **DEMOCRATS MAINTAIN** – **Senator Shelley B. Mayer (D)**, Chair of Senate Education Committee, prevailed over Republican Frank F. Murtha, who holds a doctorate in psychology from SUNY-Buffalo and works as a mental health professional, 54% to 40% with 265 of 292 election districts reporting.
- 38th Senate District (Rockland) – **REPUBLICANS PICKUP** – In a rematch from 2020, Sen. Reichlin-Melnick (D) was defeated by **Republican Bill Weber**, a certified public accountant, 49% to 46% with 286 of 286 election districts reporting.
- 39th Senate District (Part of Dutchess, Part of Orange & Part of Putnam) – **REPUBLICANS PICKUP** – Senator James Skoufis (D) opted to run in the 42nd Senate District. In the newly drawn 39th Senate District. **Republican Rob Rolison**, Mayor of Poughkeepsie, prevailed over Democrat and Working Families Party candidate Julie Shiroishi, who recently served as chief of Staff for Assemblymember Jonathan Jacobson, 51% to 45% with 261 of 261 election districts reporting.
- 40th Senate District (Part of Putnam, Part of Rockland & Part of Westchester) – **DEMOCRATS MAINTAIN** – Senator Pete Harckham (D), Chair of Senate Committee on Alcoholism and Substance Abuse prevailed over Republican Gina M. Arena, administrative assistant for Westchester County Laboratories & Research 53% to 47.54% with 95% of the vote in.
- 41st Senate District (Columbia, Greene, Part of Dutchess & Part of Ulster) – **DEMOCRATIC PICKUP** – As a result of redistricting two incumbents squared off: **Senator Michelle Hinchey (D)** who prevailed over Susan J. Serino (R/C/I) 52% to 47% with 297 of 297 election districts reporting.

- 42nd Senate District (Part of Orange) – **DEMOCRATIC PICKUP** – **Senator James Skoufis (D)**, who currently represents the 39th Senate District, ran in the 42nd district and prevailed over Republican/Conservative Dorey Houle, Monroe town councilwoman, former college lecturer and director of the American Sign Language program at CUNY College of Staten Island, 49% to 48% with 275 of 275 election districts reporting.
- 43rd Senate District (Rensselaer, Part of Albany & Part of Washington) – **REPUBLICANS PICKUP** – **Republican/Conservative Jacob C. Ashby**, current Assemblymember for 107th Assembly District prevailed over Democrat Andrea Smyth, former CEO for Coalition for Children's Behavioral Health, 51% to 45% with 255 of 255 election districts reporting.
- 44th Senate District (Saratoga & Part of Schenectady) – **REPUBLICANS MAINTAIN** – **Senator James N. Tedisco (R)** opted to run in the 44th district following the redistricting process and prevailed over Democrat and Working Families Party candidate Michelle Ostrelch, a member of the Schenectady County Legislature, 56% to 42% with 248 of 248 election districts reporting.
- 45th Senate District (Clinton, Essex, Franklin, Warren, Part of St. Lawrence & Part of Washington) – **REPUBLICANS MAINTAIN** – **Senator Daniel G. Stec (R/C)** prevailed over Democrat Jean A. Lapper, a certified public accountant, 59% to 38% with 227 of 227 election districts reporting.
- 46th Senate District (Montgomery, Part of Albany & Part of Schenectady) – **DEMOCRATS MAINTAIN** – Longtime Senator Neil Breslin (D), who currently represents the 44th Senate District and chairs the Senate Insurance Committee, prevailed over Republican/Conservative Richard M. Amedure, Jr., a veteran and state trooper, 53% to 44% with 307 of 307 election districts reporting.
- 47th Senate District (Part of New York) – **DEMOCRATS MAINTAIN** – **Senator Brad Hoylman (D)**, who currently represents the 27th Senate District, prevailed over Medical Freedom candidate and Robert P. Bobrick and Parent Party candidate Maria Danzilo with 84% with 171 of 171 election districts reporting.
- 48th Senate District (Cayuga & Part of Onondaga) – **DEMOCRATS MAINTAIN** – **Senator Rachel May (D)** prevailed over Republican Julie Abbott, former television journalist, former school board vice president and current Onondaga County Legislator, and Conservative Justin M. Coretti, an attorney, with 49% of the vote with 276 of 276 election districts reporting.
- 50th Senate District (Part of Onondaga & Part of Oswego) – **TOO CLOSE TO CALL** – Freshman Senator John W. Mannion (D), Chair of Senate Committee on Disabilities, is trailing **Republican Rebecca Shiroff**, a former part-owner and spokesperson for Metro Mattress and currently a programs analyst, 48.97% to 49.29% with 289 of 289 election districts (difference of 396 votes). This process may take several weeks. It's important for every vote to be counted, for the process to play out with openness and transparency, and for the results to be respected and honored, regardless of the outcome."

VIII. NYS Assembly

Heading into the 2022 election cycle, Democrats held 107 of the 150 seats in the chamber while Republicans held 43. As a result of Tuesday's elections, Democrats are expected to hold between 100 to 103 with several longtime Democratic incumbents having lost including Assemblymember Steven Englebright (4th district), Assemblymember Steven Cymbrowitz (45th district) and Assemblymember Peter Abbate (49th district), and several races are still too close to call. If this holds, Assembly Democrats will have maintained at least 100 seats, which is the threshold for a supermajority and the ability to override a gubernatorial veto. Here is a breakdown:

- 3rd Assembly District (Part of Suffolk) – **REPUBLICANS MAINTAIN** – **Assemblymember Joseph P. De Stefano (R/C)** leads Democrat Trina R. Miles, a former employee of the Suffolk County Board of Elections, 61% to 34% with 70 of 74 election districts reporting.
- 4th Assembly District (Part of Suffolk) – **REPUBLICANS PICKUP** – Republican /Conservative Edward A. Flood an attorney, small business and a prosecutor for the Town of Brookhaven, 4 prevailed over longtime Assemblymember Steven C. - 11th Assembly District (Part of Nassau & Part of Suffolk) – **TOO CLOSE TO CALL** – **Assemblymember Kimberly Jean-Pierre (D)** prevailed over Republican/Conservative Christopher Sperber, a former special courts clerk, 48.28% to 47.91%, a difference of 136 votes, with 86 of 86 election districts reporting. (Race has not officially been called)
- 12th Assembly District (Part of Suffolk) – **REPUBLICANS MAINTAIN** – **Assemblymember Keith Brown (R/C)** prevailed over Democrat Cooper Macco, a lawyer, 56% to 41% with 119 of 119 election districts reporting.
- 13th Assembly District (Part of Nassau) – **DEMOCRATS MAINTAIN** – **Assemblymember Charles Lavine (D)** prevailed over Republican/Conservative Ruka Anzai 52% to 44% with 102 of 102 election districts reporting.

- 15th Assembly District (Part of Nassau) – **OPEN SEAT: REPUBLICAN MAINTAIN** – Assemblymember Michael Montesano (R) resigned from the Assembly earlier this summer, to become a district court judge with the New York State Unified Courts. **Republican/Conservative Jake Ryan Blumencranz**, an insurance broker who received the endorsement of Newsday prevailed over Democrat Amanda R. Field, a Plainview Water District commissioner and member of the New York State Conference of Local Mental Hygiene Directors Regional Planning Consortium, 55% to 40% with 112 of 112 election districts reporting.
- 16th Assembly District (Part of Nassau) – **DEMOCRATS MAINTAIN** – Assemblymember Gina L. Sillitti (D) prevailed over Republican/Conservative Vibhuti N. Jha, strategic advisor at the Seattle-based Human Potential Project who previously held leadership role at American Express Bank, 50% to 47% with 109 of 109 election districts reporting.
- 17th Assembly District (Part of Nassau) – **REPUBLICANS MAINTAIN** – **Assemblymember John K. Mikulin (R/C) prevailed** over Democrat Paul R. Kaminsky 64% to 32% with 95 of 95 election districts reporting.
- 18th Assembly District (Part of Nassau) – **DEMOCRATS MAINTAIN** – **Assemblymember Taylor R. Darling (D)** prevailed over Republican/Conservative Lamont E. Castronuova, cohost of the Newsmax show "Wise Guys" who holds a degree in broadcast communications is from Hofstra University 56% to 40% with 89 of 89 election districts reporting.
- 23rd Assembly District (Part of Queens) – **TOO CLOSE TO CALL** – **Assemblymember Stacey G. Pheffer Amato (D)** is trailing Republican/Conservative Thomas P. Sullivan, a financial service industry and professional and veteran, 49.24% to 48.44% a difference of 246 votes with 105 of 105 election districts reporting. Asm. Pheffer-Amato released a statement on November 10 stating in part, "My race is too close to call and I want to fill you all in on the process. It is important for EVERY vote to be counted. The Board of Elections is currently awaiting absentee, military, overseas, and affidavit ballots to be received. While it may take some time, we must embrace the rules and laws in order to have an official result. We will keep everyone posted and I look forward to seeing the final results and continuing to serve the people of the 23rd Assembly District."

- 40th Assembly District (Part of Queens County) – **DEMOCRATS MAINTAIN** – **Assemblymember Ron Kim (D)**, Chair of Assembly Aging Committee, prevailed over Republican/Conservative Sharon A. Liao, a social activist, 49% to 45% with 61 of 61 election districts reporting.

- 60th Assembly District (Part of Kings County) – **DEMOCRATS MAINTAIN** – Assemblymember Nikki Lucas, who won a February 15, 2022, special election to fill the seat vacated by Assemblymember Charles Barron who was elected to the New York City Council prevailed in the Democratic primary over Keron W. Alleyne. In the general election, **Assemblymember Nikki Lucas**, prevailed over Working Families Party candidate Keron W. Alleyne 84% to 6% with 61 of 61 election districts reporting.
- 63rd Assembly District (Part of Richmond County) – **OPEN SEAT: REPUBLICANS PICKUP** – Assemblymember Michael Cusick opted to not seek re-election. **Republican/Conservative Sam T. Argenziano, a former chief of staff for Assemblymember Cusick and current Deputy Commissioner for Richmond County Public Administrator, 54% to 44% with 77 of 77 election districts reporting.

- 82nd Assembly District (Part of Bronx) – **DEMOCRATS MAINTAIN** – **Assemblymember Michael R. Benedetto (D)**, Chair of Assembly Education Committee, prevailed over Republican/Conservative John M. Greaney, Jr. 62% to 32% with 85 of 85 election districts reporting.
