



There is an opening in Families Together in NYS, Inc., Youth Power, which is the statewide network of young people who have been labeled and are seeking change. Through peer-to-peer mentoring, we empower young people to be active citizens that are aware of government operations, their rights, and the ability to use their voices to influence policies, practices, regulations, and laws.

POSITION: The DEI Youth Engagement Specialist Position – The DEI Youth Engagement Specialist position is a grant-funded Youth Peer Role that requires an understanding of the concepts of institutional and structural racism and their impact on youth and young adults from underserved and underrepresented communities. The position requires knowledge of diversity, equity, inclusion, anti-racism, anti-oppression, social justice, comfort with entering into diverse spaces, and incorporating the lenses of Youth/Young adults. The youth engagement specialist must demonstrate effective youth/young adult leadership and engagement including connecting local youth groups, coordinating regional and statewide youth/young adult advocacy efforts, and provide technical assistance and training on youth/young adult empowerment, youth-guided practice, and youth peer services with a DEI lens. Primary responsibilities of this position include, but are not limited to:

- Establish contacts and collaborators throughout the state with a focus on underserved communities.
- Participation in Youth Advisory Councils, Committees, Boards on the local and statewide level.
- Act as an interdepartmental liaison with a DEI and Youth/ Young adult-infused lens.
- Promote youth/young adult involvement, empowerment, and peer support with a DEI lens
- Support and enhance Regional Youth Partners to promote a sense of belonging and success for youth from traditionally marginalized populations.
- Help Develop and Co-facilitate training and educating for youth, adults and peer support workforce
- Increase youth involvement and advocacy across child-serving systems
- Experience serving individuals from historically marginalized/oppressed populations.
- Experience working within diversity with a focus on equity and inclusion.
- Ability to cultivate and develop inclusive and equitable working relationships with Youth, youth-serving organizations, and community members from historically marginalized and oppressed communities.
- Experience in promoting, creating, or participating in youth-led initiatives.
- Experience in grassroots outreach and systems advocacy

- Must be able to travel across the state
